BC Soccer Short Term Event Player Permit

A BC Soccer Short-Term Event Player Permit enables a member organization/affiliated club the ability to permit individuals who are otherwise unregistered players to participate in a BC Soccer sanctioned tournament/event that lasts no longer than 10 days. The fee per player per permit is \$15.75 (includes GST). A form to request Short Term Event Player Permits and provide participant information will be provided to the Tournament/Event Registrar (Main Contact) who is responsible to submit participant information and fees a minimum of 5 days prior to the tournament's start date.
